NEW AGENDA ITEMS:

1. **Req. #2023-0017 – 247 W. Olive Avenue. Resident requests installation of a blue curb.**

3. **Req. #2023-0019 – S. Primrose Avenue between W. Lemon Avenue and W. Colorado Avenue. Resident requests extension of red curb.**

It was moved by Committee member Santilena, seconded by Committee member Gibson to approve the installation of 20 feet of red curb. The motion carried with a 4-0 vote.
