PH-1 Conditional Use Permit CUP2023-0002

102 West Huntington Drive, Chantel Hoffert for T.P. Heritage Inn of Monrovia, LLC, Applicant

Request: Applicant is requesting a Conditional Use Permit to allow the incidental sale of beer, wine and distilled spirits for on-site consumption (Type 70 ABC License) for a new hotel, TownePlace Suites by Marriott. The project is located in the O/RD/LM (Office / Research and Development / Manufacturing) zone. Determine that the project is consistent with the Mitigated Negative Declaration adopted on August 15, 2018 by the City Council in conjunction with the Monrovia TownePlace Suites Project pursuant to the Public Resources Code 21083.3 and CEQA Guidelines sections 15162, 15168, and 15183 and is exempt from the requirement that additional environmental documentation be prepared.
