

**MINUTES OF THE REGULAR MEETING OF THE

The committee received an update that staff will install speed legends, a centerline stripe, and a high visibility crosswalk at the intersection of Bradbury Road and Lemon Avenue as part of the Renewal Northeast construction.

5. **Req. #2020-007 – Hacienda Drive from Lemon Avenue to Orange Avenue:** Resident requests installation of speed humps. The committee received an update that staff will install speed limit signs and speed legends at mid-block as part of the Renewal Northeast construction.
