REPORTS ON PREVIOUS AGENDA ITEMS

 Req. #2020-001 – Olive Avenue and Mayflower Avenue: Resident requests to increase pedestrian safety at intersection of Olive Avenue and Mayflower Avenue. Recommendation: Staff recommends removal of the intersections' southern crosswalk and installation of "Keep Clear" pavement markings to facilitate turns from Olive Avenue onto Mayflower Avenue.

- 1. Req. #2020-008 132 West Chestnut Avenue: Resident is requesting installing a Loading Zone directly adjacent to 120 or 132 West Chestnut Avenue.

 Recommendation: Staff recommends installation of a temporary green curb and to bring back the request for further action within one year of the date of installation.
- Req. #2020-009 Mountain Avenue between Valley View and Mountain View: Resident is requesting installation of speed humps.
 Recommendation: Staff recommends the Committee provide feedback on the findings of the initial speed study and traffic calming options to resolve the request.
