TITLE: Canyon Park and Hillside Wilderness Preserve Patrol Update for February 2024.

OBJECTIVE: To provide an update on incidents, maintenance, and public comments related to Canyon Park and the Hillside Wilderness Preserve (HWP) recorded for the month of February 2024.

BACKGROUND: For over a century, Canyon Park has been used as a recreational park by visitors and Monrovia residents. Services in Canyon Park include special events; Naturalist led night hikes, interpretive tours, a Nature Center, trails, a waterfall, and views of the San Gabriel Valley. In addition, Naturalists and volunteers maintain the trail systems and facilities.

In 2016, the City opened over 4.5 miles of HWP trials providing passive recreational opportunities for the community. Park Naturalists patrol the HWP and urban parks two times a day by vehicle, utility terrain vehicle and foot. In September 2020, the Bobcat Fire forced the closure of Canyon Park and HWP for an extended period of time, as the areas were unsafe and significant repairs were needed. Since then, limited hiking opportunities in San Gabriel Valley has increased amount of daily visitors to HWP, primarily in Ridgeside and Cloverleaf access points.

The bid for the renovation of Canyon Park have closed and the award of contract is expected to go to City Council on Tuesday, March 19. The project estimate is \$14 million. Some of the general scope of work will include, replacing roadway in segments of the park, changing the cross-slope of the roadway to prevent future debris from flowing directly down the center of the park, replacing all parking lots and adding approximately 24 new parking spaces, replacing the water main, installing a booster pump to feed water from the Oakglade tank, and removing the old Canyon Park water tank, installing a 6" sewer line and removing septic tanks, repairing damaged culverts, guardrails, walls, etc. and one of the exciting components of the park project is the addition of approximately 10 new features or enhancements to the park.

ANALYSIS: During the month of February 2024, Canyon Park Volunteers completed 102 hours of maintenance in Canyon Park. Maintenance performance included brush clearance, debris removal off the trail, trail improvements. The Canyon Park Volunteer Trail Crew have been vital to responding to trail clean up from havy rainstorm events throughout the month of February.

Canyon Park Staff welcomed back Managed Career Solutions (MCS) to Canyon Park and Hillside Wilderness Preserve to assist with post rainstorm disaster clean up. MCS is a labor group that gives work experience helping their participants prepare themselves in transition to skilled work force. The focus of MCS for Monrovia is to help Canyon Park and HWP staff by repairing and improving hiking trials, removing invasive speices from our eco system, and responding to debris clean from major rainstorms.

MCS has been a vital help in past years as Canyon Park and HWP comes out of post fire and rainstorm disasters from the past years.

Canyon Park Staff installed the first of possible many Eco Counters in HWP. Eco Counter is a pedestrian counting device that will track data showing how or trails are beign use in our preserve. Ridgeside was chosen as the first access point location that will start collecting data starting the month of March. As hiking and mountain bikes pass the pedestrian counter, an invisible beam (similar to a garage door safety reflector) will detect, count, and record the data to outlay a variety of reports that will give us a true understanding how are trails are being used on our hiking trails.

Serveral cubic yards of base gravel was placed on the Lower Clamshell Motorway service road trail in HWP. This base gravel is used to stabilize the saturated mud on the trail from days of periodic rain events. This gravel makes the trail safer for vehicular travel as city staff and residents of HWP ingress and egress to and from HWP.

RECOMMENDATION: Staff recommends the Community Services Commission move to receive and file CC-2, Canyon Park and Hillside Wilderness Preserve Patrol Update for February 2024.
