Purpose

- If a majority protest is not received, City Council will consider approving/rejecting the rate increase

Proposition 218 Process

 Proposition 218 requires that local governments give mailed notice of any propertyrelated proposed fee changes at least 45 days before holding a public hearing to discuss those changes.

• Sewer and water charges are considered property-related fees.

• On January 16, 2024, City Council authorized staff to initiate the Proposition 218 process by issuing a notice for a Public Hearing to be held on March 19, 2024.

 Additionally, there is a 120-day statute of limitations for challenging any sewer and water rate increases, if approved.

Proposition 218 Timeline

Below is a timeline of the steps completed for the Proposition 218 process:

PROPOSED SEWER & WATER RATE ADJUSTMENTS

On March 19, 2024, the City Council will hold a Public Hearing to consider changes to the sever and weter rates in Monrova. The proposed sever and weter rate adjustments are necessary to keep up with the costs of providing service and to ensure the long-term sublishability of the sever and weter operations. The City of Monrovia has not adjusted sever rates since 2020 and has not adjusted weter rates since 2022. It adjusted, the new rates would go into effect May 2, 2024, with additional annual increases in subsequent years.

The average monthly increase for a single-family residential customer is approximately \$7.71/month, which includes \$2.95/month for sever and \$4.76/month (based on 10 units of consumption) for water, effective May 2, 2024.

Background

- The City owns and operates its own sewer and water enterprises.
 - Sewer: 92 miles of sewer collection system.
 - Water: 111 miles of water pipelines, 12 reservoirs, 2 water treatment facilities, and 5 active wells.
- The City is responsible for setting user rates in compliance with California law, which requires that fees for sewer and water service do not exceed the proportional cost of service.

 The City's sewer and water rate structure should be based on generating sufficient user fee revenue to cover all costs for personnel, maintenance and operation costs, debt service (on bonds), capital improvements, and reserves. In short, operation, maintenance, and renewal of both systems should be entirely funded by user rates.

Budgeting Principles

The City Council has been committed to strong fiscal management policies.


- The City's Budget incorporates the City's five Financial Resiliency Plan (FRP) Principles.
 - FRP Principle #1 seeks to minimize subsidies to funds that should be self-sustaining (e.g., Sewer and Water Funds), and seeks to ensure that user fees are appropriate to cover the cost of providing respective City services.
- City Council has also been committed to ensuring that the City is investing in maintaining and replacing the City's infrastructure and assets, including sewer and water infrastructure.
- City Council's commitment to good financial management practices has resulted in two bond rating upgrades over the last 2 years, including an S & P upgrade for the City's water and sewer bonds (from A- to A).

Ensuring Sustainable Sewer and Water Enterprises

- As a best practice and industry standard, it is recommended that rate studies be performed every 5 years to ensure the sustainability of the utility enterprises.
 - Regular rate studies are critical to the healthy operation of the City's utilities.
 - Utility systems must keep up with rising costs and necessary capital replacements to ensure reliable and sustainable systems for the community.
 - Based on the results of the study, rates should be adjusted accordingly.
- Monrovia has not adjusted rates for several years:
 - Sewer rates were last adjusted in 2020 (Based on a 2015 rate review)
 - Water rates were last adjusted in 2022 (Based on a 2017 rate review)
 - This excludes Excess Usage Penalties adopted in March 2022. <u>The Excess Usage Penalty</u> program ended in February 2024.

Cost Increases in the City's Water and Sewer Utilities

 Although sewer and water rates have not been adjusted for several years, both utilities have experienced cost increases in all categories, including personnel, operating and maintenance costs, and capital. In fact, significant inflation occurred in 2021 and 2022.



- Given these increases, City Council approved a contract with NBS, an independent third-party consultant, to provide a rate study for sewer and an inflationary factor review for water in November 2022.
 - Staff spent significant time working closely with NBS, over the last year, to design rates that would be 8 least impactful to the community.



Sewer Rate Study

Sewer Rate Study Objectives

- Rates should be designed to:
 - Be proportional to the cost of service (i.e., the cost to serve each customer or customer class)
 - Be equitable & non-discriminating
 - Provide ease of administration and understanding
 - Provide revenue stability
- Revenue from rates should cover <u>all costs of operating the system</u>, which includes:
 - Maintenance and operations costs
 - Capital costs
 - Annual debt service payment on bonds
 - Funding to maintain adequate reserve levels
- Non-rate revenues, such as interest income, are netted against costs


Sewer Rate Study

- Based on the sewer rate study prepared by NBS, the proposed rate adjustments take into consideration the City's ongoing operating costs and necessary capital improvements that will allow the City to continue to provide the community with safe and reliable sewer service.
- The proposed rate adjustment covers five fiscal years and includes funding for capital improvement projects identified as part of the Five-Year CIP Program, as follows:

Comprehensive Street Improvement Project (Sewer Portion)	\$568,500

Single-Family Residential Rate

- Overall, single-family residential customers constitute 73 percent of customers.
- The sewer rate proposal would result in the following increases for a single-family residential customer each month:

FY 2024-25 (Effective 7/1/24)	\$1.64
FY 2025-26 (Effective 7/1/25)	\$0.71
FY 2026-27 (Effective 7/1/26)	\$0.75
FY 2027-28 (Effective 7/1/27)	\$0.79
Total 5-Year Increase	\$6.84

 Over the five-year period, the monthly cost for sewer for a single-family residential customer will increase by a cumulative total of \$6.84 over the five-year period.

Sewer Rates - Survey Data

As part of the overall fee analysis, staff also evaluated survey data from neighboring communities for a single-family residential customer. Monrovia has the third lowest rate in the region (before and after the proposed adjustment).

Water Rate Adjustments

Water Enterprise Costs

• The water enterprise has approximately 9,500 customers that rely on the City to provide them clean water every day.

It costs approximately \$14 million/year to operate our system.

 Over the last several years, like the sewer enterprise, the City has also experienced cost increases in the water enterprise.

 The proposed adjustments would provide approximately \$962,000 in additional funding for maintenance and operations costs and capital projects that have been approved as part of the City's Five-Year CIP. (list provided on next slide)

Water Rate Adjustments

 A comprehensive water rate study was completed in 2017. For this review, staff verified that the cost categories evaluated in 2017 are still accurate for current operations and maintenance.

 For this proposed adjustment, the City retained NBS to calculate and propose water rate adjustments based on an applicable inflation factor to help keep up with escalating costs in the water utility.

- NBS utilized the Construction Cost Index (CCI) as the basis for the proposed water rate adjustment of 7.2%.
 - It should be noted that total US inflationary growth for 2021 and 2022 was 13.5%; however, a rate adjustment of only 7.2%, based on CCI, is being proposed.

Recommended Water Rates (Most Common Rates)

- This table includes a list of the most common customer rates.
- A full listing of all rates is included in Ordinance 2024-04.
- Rates are proposed to be effective May 2, 2024.
- An annual CCI adjustment is proposed for an additional four years based on the March CCI each year. Additional increases will begin July 1, 2025 though July 1, 2028.

Single-Family Residential Rate

- Overall, single-family residential customers constitute more than 70 percent of customers.
- The water rate proposal would result in the estimated increases of \$4.76 for a single-family residential customer using 10 units of consumption per month.

Estimated Monthly Increase–Sewer & Water

• Overall, sewer and water rate adjustments propose modest increases.

• The combined estimated monthly increase for a single-family residential customer with sewer and water (based on 10 units of water usage) is \$7.71 per month, effective 5/2/24, as follows:

Sewer Increase	\$2.95
Water Increase	\$4.76
Total Estimated Monthly Increase – Sewer and Water	\$7.71

• It is also important to note that discount programs will still be offered to seniors, veterans, low-income, and Lifeline customers.

Summary

- Overall, sewer and water rate adjustments propose modest adjustments.
- A rate adjustment has not been proposed since 2020 for sewer rates, and for water rates, an increase has not been proposed since 2022.
- However, to keep up with the cost of providing service, and to ensure a well-managed and sustainable utility, these rate adjustments are necessary to ensure the long-term sustainability of the sewer and water operations.
- The combined estimated monthly increase for sewer and water for a single-family residential customer (based on 10 units of water usage) is \$7.71 per month, effective 5/2/24.
- A comprehensive list of recommended adjustments is included in Ordinance 2024-04.
- Additionally, Resolution No. 2024-16 authorizes the continuation of the discount programs
 offered for sewer and water rates.

Staff Recommendation

 Staff recommends that the City Council open the public hearing, take public input, close the public hearing, and then direct the City Clerk to determine if a majority protest of the proposed sewer and water fee adjustments exists.

 If a majority protest does not exist, staff recommends that the City Council proceed with the introduction of Ordinance No. 2024-04, waive further reading, and adopt the Ordinance on April 2, 2024, while also approving Resolution No. 2024-16, adopting a discounted rate schedule for the newly adjusted rates.
