RESOLUTION NO. 2024-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MONROVIA, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON TUESDAY, MARCH 5, 2024, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW.

WHEREAS, a General Municipal Election was held and conducted in the City of Monrovia, California, on Tuesday, March 5, 2024, in conjunction with the Statewide Primary Election, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed by the Registrar of Voters of Los Angeles County, and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MONROVIA, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. The whole number of ballots cast at vote centers, including provisional ballots, was 2,047. The whole number of vote by mail ballots cast was 7,244. When combined, a total of 9,291 ballots were cast in the General Municipal Election.

SECTION 2. The names of persons voted for at the election for Mayor, in ballot order, are as follows:

Becky A. Shevlin Larry J. Spicer

The names of persons voted for at the election for the two available offices of Member of the City Council, in ballot order, are as follows:

Sergio Jimenez Edward Belden Jesus Rojas Antoinette Mushet

The name of person voted for at the election for City Treasurer is as follows:

Janet Wall

SECTION 3. The number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates were as listed in Exhibit "A" attached.

SECTION 4. The City Council does declare and determine that: Becky A. Shevlin was elected as Mayor for the full term of two (2) years; Sergio Jimenez was elected as Member of the

City Council for the full term of four (4) years; Edward Belden was elected as Member of the City Council for the full term of four (4) years; Janet Wall was elected as City Treasurer for the partial term of two (2) years.

SECTION 5. That the City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct to each person, and (5) The total number of votes given to each person, all as set forth in Exhibit A.

SECTION 6. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 7. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
