Dear City Council Members and leaders,

Due to recent behavior I have seen first hand by the management team and staff at the last two board meetings and even well before that, I have lost faith in the current team's ability to fulfill its mission statement as a community media resource for all Monrovians and the city I've always called home. I've seen some board members attempting to adopt policies to help matters but the studio itself has lost its way in my opinion.

As I mentioned at their last board meeting, I just don't see quality production coming out of the studio. As a 30 plus year professional in media production, I still see low production value with numerous basic mistakes across the studio produced segments. I don't see much production at all from community producers like myself. I only see token small productions that are simple filming of small community events by staff. Events that are not requested to be covered by the contract with the city. The resources used seem to be taken from resources that are supposed to be used for community producers.

My concern is the studio is apparently being ran according to the self interest of a small clique of people connected to the management team at the expense of the community as a whole. This is clearly evident by the productions listed on the schedule for the KGEM and KMAC channels.

Five years ago, when the current management team took over the studio, the community was promised a better and more professionally led studio. I did my part by spending hundreds of hours producing Hollywood caliber animations and 3D rendered still for special events and productions aired by the studio.

I just don't see the current management and staff having improved the community media studio as promised five years ago. I definitely do not see the potential for them to bring the studio and Monrovia community media into the future, catching up to other regional community media stations that have done much better.

I request that the city look into drawing up a new more progressive contract leading Monrovia's community media movement into the future and putting it up for RFP to find an organization with the ability to deliver better results as promised and wanted in our fine city.
