The City of Monrovia is accepting designs for the third annual Art in Public Places Tree Ornament Contest. Artists are invited to submit a design that will be transferred to a ceramic ornament with a three-inch diameter (sample templates on page two). To celebrate [Monrovia’s All-America City Award](#), the 2024 design theme is All-America Holiday. The selected artist will receive a \$500 stipend and have their name listed on the back of the ornament. Ornaments will be sold on [Monrovia’s Online Store](#). Any proceeds will support Monrovia’s Art in Public Places programs. **Entries must be submitted by October 6, 2024.**



Design Requirements

- + Reflect the theme, All-America Holiday
- + Can either be black and white or color
- + Needs to include “Monrovia All America City”
- + Submitted in a PNG format (minimum 300 PPI)
- + Be family friendly

Submittal Requirements

- + Open to artists of all ages
- + Email the complete application and digital image to Kerri Zessau at kzessau@ci.monrovia.ca.us. The email subject line needs to read “**2024 ORNAMENT CONTEST**”
- + Artist may submit up to two designs
- + Incomplete applications or applications received after the due date will be disqualified

Design Selection

- + The Art in Public Places (AIPP) Committee will select the design
- + Designs will be evaluated on capturing the spirit of the theme, artistic excellence, innovation and originality

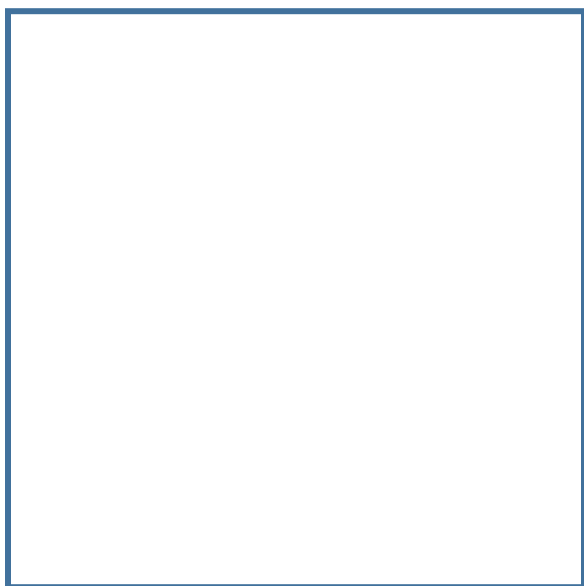
