MATTERS ON THE AGENDA: If you wish to address the Planning Commission on a matter on the agenda, please wait until the Chair opens the public hearing or calls for public comment on that matter. For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

AGENDA ITEMS: The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

Request: Applicant is requesting a Conditional Use Permit CUP2024-0007 for a State Alcohol Beverage Control (ABC) license (Type 41) for the incidental sale and service of beer and wine for a new restaurant, Fillet, located at 618 South Myrtle Avenue. The subject property is located in the HCD (Historic Commercial Downtown) zone.

Determine that the project is Categorically Exempt (Class 1) pursuant to the California Environmental Quality Act (CEQA).

923 South 10th Avenue (APN: 5780-019-011), Arcadia, California, James Troyer, Applicant

Request: Amend the Land Use Element of the General Plan and the Official Zoning Map of the City of Monrovia to designate the property at 923 South 10th Avenue, Arcadia as Residential Medium Density and Public/Quasi-Public, and RM 4000 and P/QP in connection with the annexation of territory known as Reorganization No. 2023-02 to the City of Monrovia and detachment from the City of Arcadia.

An Initial Study was completed in accordance with the California Environmental Quality Act (CEQA) and a Notice of Intent to adopt a Negative Declaration for the project was distributed for a 20-day public review and comment period from October 11, 2024 through October 31, 2024.

Recommendation: Adopt Planning Commission Resolution No. PCR2024-57 and Recommend approval to City Council
