# 1. <u>Req: #2015-177: Permit Parking on Hidden Valley – Alta Vista to end of road – Resident</u> <u>Only Parking</u>

A petition will be circulated by residents to approve Resident Only Permit Parking – need 50% plus one to achieve the goal. No updates. *Carry over to October 15, 2015 meeting.* 

# 2. <u>Req: #2015-180: Corner of 5<sup>th</sup> & Genoa Street – Replace 2 way stop sign with 4 way stop sign.</u>

Staff recommends work order to extend red curbs at all corners to allow for better visibility (location does not meet the criteria for a warrant study for a 4 way stop). *Closed* 

#### 3. Req: #2015-182: Encino Way (Encino Ave & Encino Way) – Parking Issue

Staff performed a site visit and stated that the street is a very small cul-de-sac with only 5 houses. Painting the curb will result in no parking for the residents. Staff will reach out to residents and determine best solution. No update. *Carry over to October 15, 2015 meeting.* 

# 4. Req: #2015-183: California & Duarte Rd – Traffic Issue

Staff reviewed striping is complete. Traffic signal at Myrtle was adjusted. Closed

# 5. Req: #2015-184: Encino Way (South of Duarte Road) - Speeding

Staff performed a site visit. Staff recommends work order to paint/extend red curb at corners to allow for better visibility. *Closed* 

#### 6. Reg: #2015-185: 646 N Canyon Blvd – Restricted parking in front of residence

Property is near Canyon Crest cutoff, can't restrict parking in area. PD will continue to monitor area for vandalism. Staff to provide other options. *Carry over to October 15, 2015 meeting.* 

# 7. Reg: #2015-186: 1300 Block of Sherman Ave - Permit Parking Only

Staff to provide resident with a petition and advise them of the process. *Carry over to October 15, 2015 meeting.* 

# 8. Req: #2015-187: 710-730 N Canyon – No Stopping/No Parking Sign and Red Curb

Staff performed a site visit. Staff recommends work order for new signage and refresh red curbs. *Closed* 

#### 9. Req: #2015-188: Gold Line Mayflower/Huntington Area

Stop sign warrant study needed on Evergreen & Mayflower. No Stopping on Tracks sign installed and Not a Crosswalk signs ordered. *Carry over to October 15, 2015 meeting.* 

#### 10. Req: #2015-189: Mauna Loa/Highland - Speeding

PD placed a data box. Over a 4 day period, 311 vehicles or which 9 were citable (less than 3%). Not considered a speeding issue. *Closed* 

#### 11. Req: #2015-190: 100 Block E Cypress Between Myrtle & Ivy - Speeding

Staff recommends work order to add increased signage, trim foliage, and install stenciling. *Closed* 

#### 12. Req: #2015-191: Olive & California – 4 way stop

PD patrolled area over the last month. No large trucks were blocking the view. Staff will review for red curb extension. *Carry over to October 15, 2015 meeting.* 

#### 13. Req: #2015-192: 228 E Olive Ave – Blue Curb in front of house

Committee approved ADA blue curb in front of house. Work order created. *Closed* 

#### 14. Req: #2015-193: Alta Vista & West Chestnut – 4 way stop

Data box will be placed on southbound Alta Vista to Chestnut. *Carry over to October 15, 2015 meeting.* 

#### 15. <u>Req: #2015-194: 1048 Norumbega Dr – Place a mirror on pole for better view of traffic</u> Staff to perform site visit to determine if private pole is being used. *Carry over to October 15.*

#### 16. Req: #2015-195: Olive and Primrose – Permit Parking only
