**C. FOLLOW-UP ITEMS**

1. **Req: #2015-177: Permit Parking on Hidden Valley – Alta Vista to end of road – Resident Only Parking** – Residents to circulate petition.
2. **Req: #2015-179: Rear alley at 158 Grand – Debris and non-operational vehicles being stored in alley. Working on vehicles in alley late at night (6/18/15 Agenda)**  
Code Enforcement to review and report.
3. **Req: #2015-180: Corner of 5<sup>th</sup> & Genoa Street – replace 2 way stop sign with 4 way stop sign.**  
PD will check collision to see if warrant study is option. Staff will look into other measures.
4. **Req: #2015-182: Encino Way (Encino Ave & Encino Way) – Parking Issue**  
Staff to perform site visit to determine if red curb or signage. Permit parking.
5. **California & Duarte Rd. – Traffic issue**  
Not able to safely exit cemetery. Striping complete.
6. **Duarte Rd at Peck & Magnolia – Cement Barriers.**  
Cement barriers need to be more visible – paint tips (Evergreen as well).  
Ongoing Station Square construction.
7. **Mayflower at Huntington – Traffic issue**  
Speeding through alleyway behind McDonalds. Staff to review and evaluate. Refer to private property owner

8. **Encino Way (South of Duarte Rd) – Speeding**

Speed limit signs, speed bumps on Encino. Review for traffic calming options.

1. **646 N. Canyon Blvd. – Restricted parking in front of residence**

Near entrance to Canyon Park, car was broken into, trashcans were dumped on law.

2. **1323 S. Magnolia – Red Curb**

Tenants are parking and blocking some of the pedestrian crosswalks. Requesting curb be painted red.

3. **1300 Block of Sherman Ave. – Permit Only Parking**

Residents requesting permit only parking.

4. **710-730 N. Canyon – No Stopping/No Parking Sign and Red Curb**

Canyon Park area, need more signage and red curb

5. **Duarte Rd & California – Unsafe left turns into South Bound Traffic Lanes**
