C. FOLLOW-UP ITEMS

1. Req: #2014-135: Speeding Issue 5th Avenue (12/17/2014)

Citable speed is ten miles per hour (mph) over the 25 mph speed limit. Traffic numbers for two week period 2,751 vehicles traveled 5th Avenue North of Foothill. Of those vehicles, 165 vehicles could have been cited. *Closed*

2. Req: #2015-146: Overnight Permitted Parking Cypress/Alta Vista (2/6/2015)

Staff to evaluate and recommends item tabled until January 2016.

3. Req:#2015-166: Speeding on May Avenue

Citable speed is ten miles per hour (mph) over the 25 mph speed limit. Traffic numbers for two week period 2,195 vehicles traveled May Avenue. Of those vehicles, 854 vehicles could have been cited.

Recommend increased patrol and signage. *Closed*

4. Req: #2015-176: Add street sweeping sign (Monday 12pm – 4pm) on the west curb at 1527 Alasitas (cul de sac) which needs to include an end sign

Staff to follow-up with Street Division. *Closed*

5. Req: #2015-177: Permit Parking on Hidden Valley – Alta Vista to end of road – Resident Only Parking

A petition will be circulated by residents to approve Resident Only Permit Parking – need 50% plus one to achieve the goal. – *Continue to August 20, 2015 meeting.*

6. Req: #2015-178: 706 North Canyon at Ridgeside – Parking issue

Site visit complete. Staff to paint 6' red curb on each side of driveway approach. *Closed*

7. Req: #2015-179: Rear alley at 158 Grand - Debris and non-operational vehicles being stored in the alley. Working on vehicles in alley late at night

Code Enforcement will talk to resident. *Continue to August 20, 2015 meeting.*

8. **Req: #2015-180: Corner of 5th & Genoa Street – Replace 2 way stop sign with 4 way stop sign.**
4 way stop requires warrant study. PD will check collisions to see if study is warranted. Staff will look into other measures. *Continue to August 20, 2015 meeting*
9. **Req: #2015-181: Central Ave (at Sierra Auto) – Speeding through No Thru Traffic Lane**
Staff recommended refresh painting and channeling. Add Yield sign. *Closed*
10. **Req: #2015-182: Encino Way (Encino Ave & Encino Way) – Parking Issue**
Staff to perform a site visit determine if red curb, signage or permit parking only. *Continue to August 20, 2015 meeting*
