C. FOLLOW-UP ITEMS

1. Considerations for City Truck -Route Modifications

Implementation of Phase 2.

2. Req: #2014:119: Speed Bumps at 640 Bradbury Road (7/16/2014)

Stop sign warrant study to be evaluated by Traffic Engineer.

3. Req: #2014-125: Request for Pedestrian Crosswalk Olive / Magnolia Avenue (9/16/2014)

A meeting will be conducted with Mr. Marchetti, MUSD, to discuss the crosswalk.
Carry over from the March 19, 2015 meeting.

4. A. Req: #2014-131: Add Stop Signs to Sierra Vista and Valle Vista (10/15/14)

B. Req: #2014-132: Add Stop Signs to Sierra Vista South to Grand (10/15/14)

C. Req: #2014-133: Speeding Issue Grand (11/06/14)

Recommend further discussion with Police and Fire Departments. *Carry over from the March 19, 2015 meeting.*

5. Req: #2014-134: Relocate Bus Stops from Duarte /Alta Vista to Radford/ Fano (11/18/14)

Safety concerns received from residents prompted topic of possible replacement of bus stops. Mrs. Cherry will meet with Mr. Vince Marchetti to discuss the issue. *Carry over from the March 19, 2015 meeting.*

6. **Req: #2014-135: Speeding Issue 5th Avenue (12/17/14)**
Niles Boyer, Field Services Manager, Public Works to provide a follow-up. *Carry over from the March 19, 2015 meeting.*

7. **Req: #2014-137: Two-Way Stop (12/1/2014)**
Add two-way stop instead of yield in parking Lot north/south bound located in alley east/west bound between Lime/Lemon and Myrtle/Primrose.

Mrs. Cherry recommended and directed the following: Notify residents in advance via letter of the installation; create a map of the area to be affected; Mr. Angel Carrillo to present the map to MOTAB; item to be presented to Council for approval. *Carry over from the March 19, 2015 meeting.*

8. **Req: #2015-140: Speeding Issue at East/West 300 to 600 Block of Cypress (01/05/15)**
Speeding in the area is a concern. Request is to install speed bumps.

Officer Mead to provide enforcement. Provide a speed box and post speed limit.

9. **Req: #2015-145: Speeding Issue 838 Oakdale between Mountain / Shamrock (1/21/15)**
Concerns regarding speeding in the area.

Police Department will add speed box in the area for two weeks. No box yet. *Carry over from March 19, 2015 meeting.*

10. **Req: #2015-146: Overnight Permitted Parking Cypress / Alta Vista (2/6/15)**
Overnight permit parking on Cypress between Magnolia and Alta Vista and Alta Vista between Huntington and Central was requested.

To institute permit parking, resident must be in favor. Resident petition received. *Carry over from March 19, 2015 for follow-up.*

11. **Req: #2015-148: Speeding Issues on May Avenue (2/17/15)**
Will provide additional enforcement and speed box when available. Provide update at April meeting.

12. **Req: #2015-149: ADA Parking at 806 Oakdale (2/23/15)**
Resident is asking to amend the initial temporary ADA parking to a permanent one. Request was initially denied on January 15, 2015 because the area has no curb or driveway and adding an ADA parking would cause a liability to the City. Mr. Enriquez is investigation options.

13. Req: #2015-151: Left Turn Signal at the Intersection of Mountain and Lemon Ave. (2/27/15)

Resident is concerned regarding the lack of a left- turn signal at the intersection. She claims there have been several accidents at this intersection.

Mr. Carney states that turn lanes exist north and southbound, but with the way they align one another, each blocks the other's line of sight. Niles Boyer, Field Services Manager, Public Works to research funding for signal and lane alignment.

14. Req: #2015-152: Parking Concerns 335 S. Madison (3/11/15)

Parking concerns from Monrovia High School rentals in the evening and weekends; resident is suggesting parking by permit.

A follow-up with Mr. Marchetti. Provide update at April meeting

15. Agenda 03/19/15: Req: #2015-153: ADA 113 Norumbega (3/12/15)

Senior requesting handicap parking.

Niles Boyer, Field Services Manager Public Works to provide update at April meeting.

16. Agenda 03/19/15: Req: #2015-141: Permit Only Parking at 719 Ridgeside (1/13/15)

Request to post a "Permit Parking Only" sign at either side of Ridgeside due to issues with visitors leaving trash when parking in area. Provide update at April meeting.

Resident is concerned over excessive speed and use as a shortcut to freeway, and safety of children walking to school.

Resident has observed vehicles racing on 3/25 at 4:55 p.m. Requested a call back.

3. Req: #2015-157: Streets near Plymouth Elementary School

Consider turning two streets near Plymouth Elementary School to one-way streets.

4. Req: #2015-158: El Nido – Speeding

Resident requested a call back.

5. Req: #2015-159: Inquiry in to Blue Curb for Handicapped Son

Resident inquiring about getting a blue stripped curb in front of her home for her handicapped son.

6. Req: #2015-160: New dip on Sierra Vista and Grand – Vehicle Damage

Resident is concerned that there is no notification to slow for the dip. Has caused \$900 in damage to his vehicle.
