A. MINUTES FOR APPROVAL

It was moved by Tina Cherry, Community Services/Public Works Director, and seconded by Sergeant Daniel Verna, of the Monrovia Police Department to approve the minutes of the March 19, 2015 meeting; there were no objections, and the motion was unanimously approved.

C. FOLLOW-UP ITEMS

1. Considerations for City Truck - Route Modifications

The initial study did not yield enough evidence to justify route modifications. Working with the City Attorney to move forward. – *Continue to the May 21, 2015 meeting.*

2. <u>A. Req: #2014-119: Speed Bumps at 640 Bradbury Road (7/16/2014)</u>

B. Req: #2014-131: Add Stop Signs to Sierra Vista and Valle Vista (10/15/2014) C. Req: #2014-132: Add Stop Signs to Sierra Vista South to Grand (20/15/2014) D. Req: #2014-133: Speeding Issue Grand (11/6/2014)

A motion was made by Community Services/Public Works Director Tina Cherry and seconded by Management Analyst I Alfredo Enriquez to coordinate with the Traffic Engineer to develop a Speed Bump Policy. Will add speed bumps on Bradbury, north and south of Orange Avenue and on Grand. Work with Traffic Engineer to add stop signs at Sierra Vista and Valle Vista, and Sierra Vista south to Grand. Speed bumps added are not to impede safety vehicles, red curbs will also be painted at the bumps, and neighbors will be notified. – *Items A., B., and C, Closed. Item D continued to May 21, 2015 meeting.*

3. <u>Req: #2014-134: Relocate Bus Stops from Duarte/Alta Vista to Radford/Fano</u> (11/18/14)

Working with Mr. Marchetti to notify the neighborhood and parents that the bus stops will be relocated. - Item Closed

4. <u>Req: #2014-135: Speeding Issue 5th Avenue (12/17/2014)</u>

Sergeant, Daniel Verna of the Monrovia Police Department reported that enforcement is being performed at the location. A data box will be placed, and speed limit signage on May Avenue will be added. The next location will be Cypress and Oakdale. – *Continued to May 21, 2014 meeting.*

5. Req: 2014-137: Two-Way Stop (12/1/2014)

Field Services Manager, Public Works Niles Boyer will replace the Yield signs with Stop signs. – *Item Closed*

- 6. <u>Req: #2015-140: Speeding Issue at East/West 300 to 600 Block of Cypress (1/5/2015)</u> A data box will be placed at the location. Officer is citing for violations. The data box will capture additional information. – *Continued to May 21, 2015 meeting.*
- 7. <u>Req: #2015-145: Speeding Issue 838 Oakdale between Mountain/Shamrock (1/21/2015)</u> A data box will be placed ~ this is normally a quiet street. – *Continued to May 21, 2015 meeting.*

Management Analyst, Alfredo Enriquez is working with the residents to gather additional signatures for the petition. - *Continue to May 21, 2015 meeting.*

9. Req: #2015-148: Speeding Issues on May Avenue (2/17/2015

Field Services Manager, Public Works Niles Boyer; speed limit signage is visible. A data box has been placed at the location. The box will gather date/time/speed information. Sergeant Daniel Verna of the Monrovia Police Department has written a grant for additional traffic tools, if the grant is awarded, additional data boxes would be included. – *Staff will inform resident*.

10. Req: #2015-149: ADA Parking at 806 Oakdale (2/23/2015)

Staff will mark area forward from walkway to the west. – Item Closed

11. <u>Req: #2015-151: Left Turn Signal at the Intersection of Mountain and Lemon Avenue</u> (2/27/15)

A motion was made by Community Services/Public Works Director Tina Cherry and seconded by Management Analyst I Alfredo Enriquez for staff to research funding options, and the left turn pockets – north and south. This item will be sent to the Traffic Engineer. There were no objections, and the motion was unanimously approved.

- 12. <u>Req: #2015-152: Parking Concerns 335 S. Madison (3/11/2015)</u> Notify resident that Mr. Marchetti will contact them. – *Item Closed and staff will inform resident*.

Staff will establish a policy for Blue Curb ADA parking. Continued to May 21, 2015 meeting.

A motion was made by Community Services/Public Works Director Tina Cherry and seconded by Sergeant Daniel Verna of the Monrovia Police Department to recommend permit parking. Each neighbor has signed the petition. Supporting documentation (driver's license and vehicle registration) will be required in order for the Police Department to issue the permit. Will be resolved with the installation of bumps. – Item Closed

17. <u>Req: #2015-157: Consider turning two streets near Plymouth Elementary School into one-</u> way streets

Mr. Marchetti to speak with parents to understand the traffic flow. The County will need to be included in the discussion. *Item closed.*

18. Reg: #2015-158: El Nido - Speeding

Staff to perform a site visit. Will look at the data presented by the residents. – *Continue to May 21, 2015 meeting*

19. Req: #2015-159: Inquiry in to Blue Curb (711 S. Canyon) for Handicapped Son

Staff to perform a site visit. Determination pending the development of the Blue Curb ADA policy. *Continue to May 21, 2015 meeting.*

20. <u>Req: #2015-160 New dip on Sierra Vista and Grand – Vehicle Damage</u> Staff performed a site visit, and a 5mhp sign has been installed. – *Item Closed*

21. Req: #2015-161: California and Monrovista Avenues T-intersection

A motion was made by Community Services/Public Works Director Tina Cherry and seconded by Sergeant Daniel Verna of the Monrovia Police Department to forward this item to the Traffic Engineer for evaluation. There were no objections, and the motion was unanimously approved. *Continue to May 21, 2015 meeting.*
