TITLE: Hillside Wilderness Preserve Patrol Update for October 2016

OBJECTIVE: The purpose of this report is to provide the Community Services Commission with a monthly update on Hillside Wilderness Preserve Patrols.

BACKGROUND: The following information is an overview of the daily patrols of the Hillside Wilderness Preserve for October 2016. Rangers patrol four access points which include Sleepy Hollow, Ridgeside, Cloverleaf, and Highland. A minimum of two patrols per day is conducted at each access point. There was one call for service to the Pasadena Humane Society – Animal Control.

Sleepy Hollow - The Sleepy Hollow access point is located off of Norumbega Drive and the paper street Traci Lane. The access point leads to an out-and-back trail primarily used by the adjacent neighborhoods for its vista point views looking to the south. For the month of October there were no Police, Animal Control, or Fire calls.

Ridgeside - The Ridgeside access point is located off of Ridgeside Drive a quarter mile north of Briarcliff Drive. The trail is approximately one mile in length and has three vista points. The access point is the entrance leading to the Lower Clamshell Motorway and the loop where the Braunton's Milkvetch is present. For the month of October there were no Police, Animal Control, or Fire calls.

Cloverleaf - The Cloverleaf access point is located at the end of Cloverleaf Drive. The access point follows the Clamshell Motorway to Ridgeside. This access point is where Station 103 is located and the entry road to the private in holders. For the month of October there were no Police, Animal Control or Fire calls.

Highland - The Highland access point is located at the end of Highland Place. The trail is a half mile in length. On October 14, at approximately 11:45 a.m. the Park Rangers were called to report an injured male deer buck with an arrow in his neck. Pasadena Humane Society – Animal Control and California Department of Fish and Wildlife was called to assist. The male deer was not located.
