#### Full-day Preschool

1. Brief description of learning objects/activities this year:

In our Monrovia classroom, we provide a quality full-day preschool program for 24 children Monday- Friday, twelve months of the year. Our classroom curriculum, High Scope is implemented throughout the daily routine preparing children and their families to enter kindergarten in the fall. Our daily lesson plans are created and customized around each child's individual needs as we support each child in all areas of development.

#### **Head Start**

1. Brief description of learning objects/activities this year:

Our Head Start program continues to serve families through our Center Base and Home Based programs, servicing children from ages 3-5. Our learning objectives for this year have focused on how to use our data from outcomes and measures (from Desired Results Developmental Profiles) to assist in strong lesson plans that support child learning. We have introduced a new form that is used with parents to facilitate understanding of their child's progress. We have also focused on parent involvement and the importance of engaging parents, demonstrating to parents that our School Readiness Goals align to our outcomes and measures.

Our Home Based program continues to implement the Parents As Teachers curriculum which provides strong resources for parents regarding child development, supporting family well-being/need as well as the overall importance of parent involvement. This year parent educators have focused on using household items and the household environment to demonstrate that learning opportunities are always available and on-going.

#### **Surround Care**

1. Brief description of learning objects/activities this year:

Options for Learning Surround Care at Plymouth in Monrovia offers curriculum that is designed to focus on Science, Technology, Engineering, Arts, and Math (STEAM), 6 Pillars of Character (Trustworthiness, Respect, Responsibility, Fairness, Caring, and Citizenship), and aim to provide an Anti-bullying environment. Our staff at Plymouth provide opportunities to extend learning for the children and develop the skills that assist them to reach their fullest potential.
