Frequently Asked Questions

Q – Who can get served?

A – Any person who has been identified as a member of MNV or Duroc Crips gangs, or any person acting in association with gang members for the benefit of these gangs. For example, spray painting gang graffiti in a public place.

Q – What areas are affected by the injunction?

A – Any area accessible to the public that falls within the designated "safety zone."

Q – What do I do after I've been served?

A – Those who have been served must abide by all the rules set forth in the service including not engaging in any activity set forth in the prohibitions.

Q - How long will the injunction last?

A – The length of time is determined by the Court.

Q – What will happen if I violate a condition of the gang injunction?

A – The Monrovia Police Department is committed to protecting its community members by reducing all gang activity. Those found in violation of the gang injunction order will be arrested and charged with a crime. Gang Injunction

The City of Monrovia is committed to providing the safest environment possible for our community members. In an effort to maintain a safe and healthy community, the Monrovia Police Department has been charged with the enforcement of a city-wide gang injunction.

A gang injunction is a court order issued from civil court aimed at a criminal street gang designed to eliminate the public nuisance caused by the gang and its members in a designated "safety zone."

On December 18, 2009, the Court issued an injunction against the criminal street gangs of Monrovia Nuevo Varrio and the Duroc Crips, which will be enforced in the safety zone bordered on the north by Foothill Boulevard, on the west by Mayflower Avenue, on the east by Mountain Avenue, and on the south by Duarte Road.

Having been identified as a public nuisance because of their criminal and nuisance activities, members of the Monrovia Nuevo Varrio and the Duroc Crips gangs, or affiliates and/or associates acting for the benefit of the gang, are prohibited from certain activities upon service of the gang injunction order.

Prohibitions for Persons Served with the Injunction

Do Not Associate – No standing, sitting, walking, running, driving, gathering, or appearing anywhere in public with any other know Monrovia Nuevo Varrio or Duroc Crips gang member, unless school, church, intervention program, or funeral service.

Do Not Intimidate – No confronting, intimidating, annoying, harassing, threatening, challenging, provoking, assaulting, or battering anyone in the Safety Zone.

Stay Away from Weapons – Do not possess or remain in presence of guns, ammunition, or dangerous weapons.

Stay Away from Drugs – Do not sell, possess, use, or remain in the presence of drugs or drug paraphernalia.

Stay Away from Alcohol – Do not possess or remain in the presence of an open container of alcohol in public (unless in a bar, etc.) **Do Not Trespass** – Do not be present on private property or property closed to general public without written consent of owner/lawful occupant, or in the presence of the owner/lawful occupant.

Do Not Block Access – Do not block the free passage of any vehicle or person on any street, walkway, sidewalk, driveway, alleyway, building entrance or any other area of public access.

Do Not Loiter – No loitering in public for illegal purpose.

Obey Curfew – Minors (under 18 years) between 8:00 p.m. and 5:00 a.m.; Adults (18 years and over) between 10:00 p.m. and 5:00 a.m.; Stay off public property and out of public places unless going to/from school, work; or for emergency purposes. Public Place means the public way and any location open to the public.

Prohibitions apply only in the Safety Zone
