The motion carried unanimously.

Following discussion, it was moved by Councilmember Spicer, seconded by Mayor Pro Tem Blackburn, to award a contract to Sancon Engineering, Inc., for the completion of the Monrovia Renewal Southwest and Southeast Area Sewer Lining and Repair Project, approve a consultant services agreement with Merrell-Johnson Companies for construction inspection and management services, appropriate the necessary funds of \$1,025,628.75 to complete this project, and authorize the City Manager to execute the necessary documents in a form approved by the City Attorney. The motion carried unanimously.
