# MINUTES OF THE REGULAR MEETING OF THE MONROVIA CITY COUNCIL HELD TUESDAY, AUGUST 2, 2016, 7:30 P.M.

**CONVENE:** Mayor Adams convened the Regular Meeting of the Monrovia City Council of Tuesday, August 2, 2016, at 7:30 p.m. in City Council Chambers. In attendance were City Manager Oliver Chi, Assistant City Attorney Carol Lynch, and City Clerk Alice D. Atkins.

**INVOCATION:** Police Chaplain Terrence Brown led the invocation.

PLEDGE OF ALLEGIANCE: Councilmember Larry J. Spicer led the Pledge of Allegiance.

AR-1 Consultant Services Agreement with CivilSource, Inc., in an Amount not to Exceed \$165,800.00 for Design and Engineering Services related to the Huntington Drive Improvements Project, Project No. STPL-5069(014)

Sean Sullivan, Public Works Manager, reviewed the Agenda Report.

Following discussion, it was moved by Councilmember Crudgington, seconded by Mayor Pro Tem Blackburn, to approve a consultant services agreement with CivilSource, Inc., for engineering design services related to the Huntington Drive Improvements Project in an amount not to exceed \$165,800, and authorize the City Manager to execute the necessary documents in a form approved by the City Attorney. The motion carried unanimously.

# AR-2 Review of the Bob Bartlett Memorial Mosaic Program Request for Qualifications Process

Lauren Vasquez, Deputy City Manager, reviewed the Agenda Report.

It was moved by Councilmember Spicer, seconded by Councilmember Shevlin, to authorize staff to proceed with Phase II of the Bob Bartlett Memorial Mosaic Program RFQ process, including the distribution of stipends for the four identified artist finalists for a total amount not to exceed \$2,000. The motion carried unanimously.

AR-3 Letter of Support for the City of Bradbury's Request to Annex into their Jurisdiction Four (4) Parcels of Land Currently Located in the City of Monrovia

Oliver Chi, City Manager, reviewed the Agenda Report.

Following discussion, it was moved by Councilmember Crudgington, seconded by Councilmember to Spicer, to authorize staff to issue a letter of support for the City of Bradbury's efforts to annex into their community four parcels of land currently located in the City of Monrovia after receiving formal confirmation of Bradbury's agreement to reimburse the City for any lost property tax revenues from the annexation proceedings, as well as written confirmation that access to properties from Wildrose Avenue will be prohibited and that none of the lots are of sufficient size to allow development, as well as a special easement provided by Bradbury to the City to further ensure the type of development of concern to the City Council could not occur. The motion carried unanimously.

# AR-4 Governor Brown's Public Safety and Rehabilitation Act of 2016 (Proposition 57)

Jim Hunt, Police Chief, reviewed the Agenda Report, and answered questions of the City Council.

Following discussion, it was moved by Councilmember Shevlin, seconded by Councilmember Spicer, to authorize Staff to issue a letter of opposition to Proposition 57 – The Public Safety and Rehabilitation Act of 2016, enhancing the draft letter to include more of the specific consequences of the proposition should it pass. The motion carried unanimously.

AR-5 Replacement Purchase of Police Department Rifles and "Less-Than-Lethal" Shotguns from Allstate Police Equipment Company in the Amount of \$42,066.26 for Utilization by Monrovia Police Personnel in Patrol, Investigations and the Regional Tactical Team

Nels Ortlund, Police Captain, reviewed the Agenda Report and answered questions of the City Council.

It was moved by Councilmember Spicer, seconded by Councilmember Shevlin, to approve the purchase of 25 Ruger Mini-14 Rifles, 16 Remington Shotguns in "less-than-lethal" configuration, and 15 Colt Commando rifles with all accessories including slings and lights from Allstate Police Equipment Co., in the amount of \$42,066.24. The motion carried unanimously.

AR-6 Non-Binding Letter Related to Development of a Joint Powers Authority for Management of Enhanced Watershed Management Program Responsibilities

Oliver Chi, City Manager, reviewed the Agenda Report and answered questions of the City Council.

Following discussion, it was moved by Councilmember Crudgington, seconded by Councilmember Shevlin, to authorize staff to execute the attached non-binding letter regarding the creation of a Joint Powers Authority for the management of Enhanced Watershed Management Program responsibilities in the Rio Hondo / San Gabriel River Watershed Group. The motion carried unanimously.
