**MATTERS ON THE AGENDA:** If you wish to address the Planning Commission on a matter on the agenda, please wait until the Chair opens the public hearing or calls for public comment on that matter. For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

**AGENDA ITEMS:** The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

**PH-1** **Conditional Use Permit CUP2017-06, Continued**  
**925 West Olive Avenue – Applicant, Scott Kendall**

**Request:** Construct a new, two-story residential duplex totaling 2,300 square feet of living area behind an existing single-story home. This property is located in RM/RH (Residential Medium-High Density) zone. Determine that the project is Categorically Exempt (Class 3) from the California Environmental Quality Act (CEQA).

**Recommendation: Approve Conditional Use Permit CUP2017-06**

**PH-2** **Conditional Use Permit CUP2017-07 and Minor Exception ME2017-13**  
**227 West Maple Avenue - Over Town Brewing Company, LLC (Ryan McKay)**

**Request:** Allow a microbrewery in an existing industrial building that will manufacture specialty beer and offer beer sampling within a tasting room that will be open to the public. The applicant is also requesting a minor exception from Monrovia Municipal Code (MMC) 17.24 to provide 8 parking spaces in lieu of the required 9 spaces. This property is located in the M (Manufacturing) zone. Determine that the project is Categorically Exempt (Class 1) from the California Environmental Quality Act (CEQA).

**Recommendation: Approve Conditional Use Permit CUP2017-07 and Minor Exception ME2017-13**
